### PIPELINES 101

During the May 22 City Council meeting, Councilmen Orean and Whistler reported on the Barnett Shale Expo. They mentioned two presentations that are available for viewing on the Internet. For those of you who haven't found time to watch those videos yet, this article is an overview of the first of those presentations, *Pipelines 101*. It is important to remember that every gas well must have a pipeline to carry the gas to market.

Dr. John Baen, the presenter, has been in the oil and gas business for 25 years. He is a graduate of Texas A&M and a full professor at the University of North Texas.

"Nobody has all the answers. Every deal is different ...", he says. "You *will* get the call. ... If you say, 'We don't want a pipeline', the next thing you will get is a court order." He recommends that you reply with, "I will consider your best offer, just please give it to me in writing."

The presentation's predominant point is that the property owner should not draw a line in the sand and definitely should not refuse to negotiate but should demonstrate a willingness to negotiate.

Two interesting items came out during the presentation. The first is a *Star-Telegram* headline, that reads "Tarrant County property values rise 8.5%." The other comes when Dr. Baen asks, "Do you know

that we have an \$8 billion surplus in the state of Texas right now? ... And it's all because the State is getting 7% of what's coming off." He recommends joining the Texas Land and Minerals Assn.

On the subject of safety, Dr. Baen states, "Two events in 10 years in 15 counties. ... No deaths that we know of at all."

Dr. Baen offers the following information to guide the owners:

- ◆ After the well is spent, the geothermal properties down at 9,000 feet belong to the surface owner. They could be used to produce heat and air conditioning.
- ◆ Before you sign a lease, visualize how your land might look 25 to 50 years in the future, and try to route the pipeline where it will do the least harm to your property value.
- ◆ There will have to be easements for the drill site, the production site, the access road, the pipeline, meter station and, if there is one, the compressor. Easements are filed against your title and can impact your financing.
- ◆ If they put a road across your property, it belongs to the oil/gas company. If you want to move it, doing so will happen at your own expense. In your oil/gas lease, you want to specify that they may use the road, but it belongs to you. You cannot subdivide off of that road unless you own it.
- ◆ Flow lines are in your oil/gas lease, do not need an easement and can

go anywhere on your land. You won't know where they are because, generally, they're not surveyed. Pipelines are a public utility.

- ◆ Compressor stations can help a well produce much more.
- ◆ Decide whether you're going to sell them the land or lease it to them.
- ◆ Decide whether you are going to have a compressor deal or insist that the easement agreement gives you the right to install a compressor? You may want to specify that the compressor be hidden in a sound-proofed building which blends with its surroundings. Your lease should clearly identify the ownership of that building.
- ◆ Do not allow a survey until you talk with the crew on-site. Develop an understanding of the pipeline's points of origin and exit on your land, and participate in determining the best route for it to follow.
- ◆ They make offers on the rod. (A rod is 30.25 square yards.) Attempt to negotiate by the foot, instead.
- ◆ When the call comes, if you do not respond, they will show up with a court order. In a condemnation, you get nothing. The land is seized, and construction begins. If you're willing to negotiate, you'll have much more control over every facet.
- ◆ Whenever presented with documents to sign, always insist on taking the time to read and understand them first.

- ◆ If a lease agreement contains undesirable conditions, undo those conditions with an Addendum.
- ◆ Legislation giving property owners more rights, discussed in an article in the *Weatherford Democrat*, has been passed recently. To read the article, go to

To summarize, Dr. Baen offers the following guidelines:

- ◆ Be nice.
- ◆ Be friendly.
- ◆ Put it in writing.
- ◆ Get copies of proposals and routes.
- ◆ Consider everything but agree to nothing initially.
- ◆ Amendment and addendum are key to your control.
- ◆ Dollars *and* terms are both important elements.
- ◆ Consider cost of damages vs a lease bonus/pipeline easement damage tax.
- ◆ Demand two checks, one for the easement and a separate one for the damages. Payments for damages are tax free.
- ◆ Join with your neighbors.
