To the Editor,

There has been some discussion of Property Taxes lately and some criticism of my remarks about Bedford having the highest taxes. So, I thought I would update and reissue my letter to the [Star-Telegram] editor of 12/28/2006.

The truth of the matter is that even after the Tax Rollback anyone with access to the Tarrant County Web Site and a calculator will soon discover that the taxes on an owner occupied home in Bedford are still higher, much higher, than the same value home in the surrounding cities of Hurst, Euless, Colleyville and Grapevine.

I am sure this will come as a shock to many people who think Bedford has low taxes.

Tax rate is a visible but deceiving number. It does not take other things into consideration such as the General Homestead Exemption many cities, except Bedford, have in force. And Bedford is unique in that we have a Sales Tax that is supposed to reduce our property taxes. In theory, that sales tax to offset property taxes should result in lower taxes in this

city. In reality, the taxes the homeowners actually pay here are the highest of the surrounding cities even after the sales tax reduction.

Take that average Bedford Home of \$153,555 [TAD] and the city taxes, if it is owner occupied, are from 8% to 52% higher than the surrounding cities and that is just counting that part of the City Property taxes paid by the homeowner. Add back in the sales tax that "reduces" the property taxes then we are 27% to 79% higher.

The homeowner paid portion of city property taxes on that average \$153,555

home in Bedford are the same as the city property taxes on a \$231,100 home in Grapevine. That's sad!

The City Council should continue to examine every aspect of the City operation in an effort to reduce these high taxes.

Life is better in Bedford unless you own a home.
