## DEC. 18 CITY COUNCIL MEETING HIGHLIGHTS

### PERSONS TO BE HEARD

**Paul Moss** of TAK Enterprises, Inc., 3620 So. Cooper, Ste. #120, Arlington, TX requested to speak to the Council regarding a proposed 27,000 square foot up-scale retail center on Cheek-Sparger Road between Wal-Mart and Woodpark Lane. The land in question fronts on Woodpark Lane and Cheek-Sparger Road, but Mr. Moss said that this project would not have any access from Woodpark Lane. He also stated that City staff could not find any record of "street escrow fees" having been collected before. Based on these facts, Mr. Moss asked for relief from the requirement to pay street escrow fees. He added that this project should have "a tax value of about \$6 million."

Councilman Orean asked about the orientation of the building on the property. Mr. Moss replied that the back of the building will face Woodpark Lane. He said that the present plan is to leave the tree stand along Woodpark Lane as it is and to landscape the back of the building. Councilman Orean then asked staff to investigate the feasibility of abandoning the portions of Woodpark Lane which abut this project and Wal-Mart to those two landowners, respectively. He asked the staff to contact the homeowners on the north side of the cut to see how they would

feel about accessing Woodpark Lane from Cummings if the north end of the lane were to be closed and abandoned.

City Manager Queen said the staff should be able to offer more information regarding the existence of other escrows for Woodpark Lane at the Jan. 8 City Council meeting.

**Sherry Bidardel** had requested to speak to the Council, but was unable to attend.

### ITEMS APPROVED BY CONSENT

- ◆ There will be a panel of "experts" at this meeting that will make brief presentations.
- ◆ A legal representative will be present.
- ◆ Maps will be available on the web site and on boards at the meeting.
